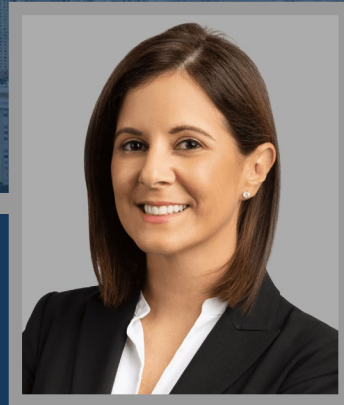


# MD MICHELLE DIVERIO
